GENERAL HOUSE RULES CIRCUIT ZANDVOORT & FORMULA 1 HEINEKEN **DUTCH GRAND PRIX**



GENERAL

These house rules apply to everyone present on the premises of Circuit Zandvoort (hereinafter referred to as the "event site"). Always follow the instructions of authorized personnel, recognizable by their clothing and/or accreditation. o as the "event site"). ARTICLE 1. LEGISLATION AND REGULATIONS

At the event site, firstly, Dutch legislation and the local ordinances (APV) of the municipality of Zandvoort apply. Visitors to events at Circuit Zandvoort, including the F1 Heineken Dutch Grand Prix (hereinafter referred to as "event"), are required to conduct themselves in accordance with public order, decency, and good morals during their stay at the event site. Visitors to this event are obliged to comply with the regulations and/or instructions given by the organizers, security personnel, medical team, and other parties involved during the event. Threats, assault, intimidation, discrimination, and any other forms of aggression are prohibited. The use of (soft) drugs is not allowed. In case of misconduct, disturbances, public urination, or violation of the house rules, visitors and/or participants may be removed from the event site. If the carrying of weapons, theft, public violence, or other illegal offences are observed, the police will be notified, and legal action will be taken.

Anyone present in the paddock, on the track, or in hospitality areas must adhere to the regulations applicable to the specific location or area for the event.

ARTICLE 2. OWN RISK AND LIABILITY

Visiting the event site is entirely at one's own risk. Visitors acknowledge that motor races, the event, and certain activities related to the event can be dangerous and agree to be present and/or participate at their own risk. The event organizers (and all their staff), Circuit Zandvoort (and all their staff), Formula One Management (and all their staff), FIA (and all their staff), suppliers (and all their staff), as well as the municipality of Zandvoort, are not liable for any damages incurred during the visit to the event or for the loss and/or theft of any belongings during the visit to the event.

Damage to (temporary) objects or properties and harm to individuals (visitors/staff) at the event will be reclaimed from the source.

ARTICLE 3. BODY SEARCH, BAG INSPECTION AND IDENTIFICATION

The organization is entitled to conduct body searches of visitors upon entry or during the duration of the event, inspect hand luggage, bags, and/or jackets, and request identification. Refusal may result in denial of access to the event site and the possibility of being removed from the event site. Visitors are required to cooperate with this. In case of refusal, the organization may deny the visitor access to the event grounds or remove the visitor from the event grounds.

ARTICLE 4. ADMISSION AND TICKETS.

Access to the enclosed event site is only possible upon the presentation of a valid ticket, along with identification. The minimum age for independently attending the event is 16 years. Younger visitors are only granted access when accompanied by an adult with a valid ticket.

Access to the event site will be denied or revoked to individuals:

- (i) Who cause any form of disturbance or exhibit aggression.
- (ii) Who possess and/or are under the influence of drugs or alcohol.
- (iii) Who are in possession of weapons. The police will be involved in such cases.
- (iv) Who cause any form of disturbance to the surroundings.
- (v) Who wear clothing representing football clubs, displays associated with motorcycle clubs (Outlaw Motorcycle Gang), or clothing or flags with nationalist symbols or expressions, except for national football shirts.
- (vi) Those who are on the circuit without a valid, demonstrable ticket/entry pass.

All event tickets must be personalized prior to the event. At the entrances of the enclosed event site, there will be checks to verify if the name on the ticket matches the name on the presented identification.

Each ticket is valid for one or more (multi-day passes & weekend) days and grants access to the event site and the specific grandstand or zone/sector indicated on the ticket. It is not automatically assumed that individuals can freely move from one grandstand or zone/sector to another. In principle, visitors can freely move from one zone or sector to another.

Visitors may only sit in the designated seats that correspond to the numbering on their ticket or in other seats assigned by the organization.

The organization has the right to claim compensation for damages from the offender(s) if the house rules are not followed.



PLEASE NOTE!

During the Formula 1 Heineken Dutch Grand Prix weekend, re-entry is not permitted after leaving the event site. Re-entry is only allowed for guests staying at the 538 Dutch Grand Prix Village.

The organization reserves the right to refuse entry or remove visitors from the premises if they do not comply with the regulations mentioned in the first article or these house rules. After removal from the premises, the visitor will no longer have access to the site.

In the interest of public order and safety, the organization reserves the right to request visitors to leave the event site at any time for security reasons. After the event, (re)admission is not permitted.

During regular events at Circuit Zandvoort, ticket holders who temporarily leave the event site are required to check out at the exit in order to regain access later.

ARTICLE 5. PROHIBITED ITEMS

The following items are not allowed to be brought to the event site:

- (i) Bags larger than A4 size and thicker than 10 cm (bags for personal medical items will receive a bag tag and undergo inspection).
- (ii) Soft or hard drugs, laughing gas, tear gas, glassware.
- (iii) Weapons such as firearms, striking-, or thrusting weapons, objects resembling weapons, or offensive objects.
- (iv) Flags with poles longer than one meter.
- (v) Spray cans (except for sunscreen, deodorant, and perfume).
- (vi) Gas stoves and (disposable) barbecues.
- (vii) Umbrellas (we recommend bringing ponchos as a precaution).
- (viii) Musical instruments, sound devices, and horns or similar items.



- (ix) All types of fireworks (firecrackers, distress signals, flares, and smoke effects)...
- (x) Provocative expressions on clothing or banners.
- (xi) Coolers (with or without contents).
- (xii) (Foldable) chairs and stools.
- (xiii) Any items that are too large to fit under a grandstand seat.
- (xiv) Pets (except for assistance dogs).
- (xv) Roller skates, inline skates, skateboards, hoverboards, scooters, bicycles, (moped) scooters, electric mobility scooters, and non-folding wheelchairs that do not fit under a grandstand.
- (xvi) Promotional materials such as flyers, leaflets, and banners (unless approved and authorized by the organization).
- (xvii) Professional film, photo, or sound equipment (unless approved and provided with accreditation by the organization).

 Detachable lenses are considered the criterion for what constitutes professional equipment.
- (xviii) Selfie sticks and drones (both on the ground and in the air).
- (xix) All other matters that, in the sole judgment of the organization and authorized personnel, may pose a danger to health, safety, and/or public order.

Visitors in possession of one or more of the aforementioned items, or any other items deemed prohibited by the organization, may be denied access to the grounds or be ordered to leave the grounds.

If the organization chooses to confiscate the prohibited items, they will be discarded in specially designated waste containers and not kept in storage. There are no lockers available to store confiscated items. In the event of the use of such items, in any manner, the organization will file a report which may lead to criminal prosecution.

ARTICLE 6. FOOD AND DRINK

As with other events and festivals, you are not allowed to bring food and drinks (except baby food and food with medical necessity). Together with our catering partner, we offer a varied range of food and drinks on the event site. In case of persistent extreme heat, the organization will initiate a heat protocol. This will be announced via the organization's media channels.

It is not permitted to take deposit packaging that belongs to the circuit or the catering operators off the circuit grounds. These must be returned before leaving the circuit in the designated bins.

ARTICLE 7. HEARING PROTECTION

At the event site, one may be exposed to sound levels exceeding 80 dBA. Wearing hearing protection is the visitor's responsibility. The organization recommends wearing hearing protection to prevent hearing damage. Hearing protection is available for purchase at the event site.

ARTICLE 8. DISABLED ACCESS AT THE TIME OF THE FORMULA 1 HEINEKEN DUTCH GRAND PRIX

PLEASE MOTE

There are no separate disabled parking spaces available during the Formula 1 Heineken Dutch Grand Prix. Wheelchairs and foldable electric mobility scooters are allowed provided they can be placed under the grandstands. If you are in possession of a regular ticket, please note that the grandstands do not have adapted seating. This means that you must enter the stands independently and or with your companion and take a seat in a regular seat.

ARTICLE 9. ALCOHOL

Visitors under the age of 18 are prohibited from buying, accepting, or consuming alcoholic beverages. Visitors are required to show identification when requested. The organization reserves the right not to sell alcohol in case of misbehaviour or intoxication.

ARTICLE 10. SMOKING

Smoking is not allowed in buildings, tents, under canopies, and other public areas on the event site. E-cigarettes and water pipes with tobacco are also included in the smoking ban.

ARTICLE 11. ADVERTISING AND PROMOTION

It is prohibited to distribute leaflets, flyers, or other (advertising) items on and around the premises without permission from the organization. Interviews, surveys, or (non)commercial promotions are also not allowed without permission from the organization. To avoid any doubt, no ticket holder is allowed to display any brand that could be aimed at promotional or marketing purposes at the event unless explicit permission has been granted by the organization in advance. The costs of removal will be charged to the distributor. Within the event site, it is not permitted to seek association (e.g., through advertising, marketing campaigns, promotions, etc.) with regard to the event, the organization, FOM, Formula 1, Circuit Zandvoort, or any other commercial entity.

ARTICLE 12. RECORDING PHOTOS AND FILM

During the event, photo, film, and sound recordings will be made. By entering the event premises, visitors implicitly grant permission to the organization and third parties to record, reproduce, publish, and/or use these recordings for promotional and safety purposes. This includes camera surveillance to maintain public order and safety at the event site.

The use of professional photo, video, or audio equipment by visitors is not allowed without permission and accreditation issued by the organization. The criterion for professional photo and camera equipment is devices "with a detachable lens". Filming using smartphones and small recording devices for personal use is allowed.

DRONES

Due to safety reasons, video and/or photo recording with drones is not permitted. Circuit Zandvoort reserves the right to grant exceptional permission to a professional and recognized party, provided that a timely and written request is submitted. Without permission and an assigned license, offenders risk fines, and a report will be made to regulatory authorities, as it constitutes a breach of safety regulations and the privacy of individuals involved.

ARTICLE 13. CONTACT

ARTICLE 14. OTHER

These house rules are subject to any additional security, public order and safety conditions imposed by the government or by the decision of the organization itself. The organization is therefore authorised to amend these house rules unilaterally at any time and will publish the amended house rules on the websites www.circuitzandvoort.nl and www.dutchgp.com.

ARTICLE 15. CONTINGENCY

In situations not covered by the house rules, the organization will decide on possible measures to be taken.
